

Tate Approved Positile List 10/17/24

1. Carpet must be textured loop.
2. Light colors with minimal or no pattern tend to telegraph the Positile buttons more than dark colors and busy patterns.

3. Carpet must have GlasBac backing.

4. Upon request, Tate will do Positile conversion on up to 9 carpet tiles for dealer evaluation.

It is the dealer's responsibility to determine if the style is acceptable for their project.

5. Lighter face weight carpets tend to telegraph the Positile buttons more than heavier face weights.

We will test lighter face weights, but a good rule of thumb is 16 to 18 ozs. Minimum.

It is important to maintain the module size during installation. It is critical that the grid size is not less than 24". Care must be taken that the floor is not installed too tight or too loose. Panels should be easily removable without binding. Panel grid should be no less than 24' and no greater than 24' 1/8" when measured across 12 panels. This also causes a slight gap between carpet tiles ensuring a proper fit without edge bunching or excessive gaps. Proper installation of the access floor panels and Positile carpet tile are critical to ensuring the success of the installation and proper sizing of these gaps. Refer to the Tate's web-site for important guidelines (Positile Installation).

Even when properly controlled, these gaps can affect the seaming of the installation and become more visually apparent especially when using light, solid colored tiles. Darker colors, patterned tiles, and quarter turning of tiles all are effective steps to minimize the visual impact of seams, however, they are a part of the inherent design of Positile and the customer must be informed in order to set their expectations.
